


FTSE Venture Capital Index

DECEMBER 2024

The FTSE Venture Capital Index seeks to replicate the performance of the FTSE Venture Capital Benchmark Index through a combination of liquid, publicly listed assets. The Index is calculated from the performance of the individual venture capital sector portfolios. The FTSE VC Index is the first index to allow liquid access to the gross performance of the venture capital industry through index-linked investment products. The FTSE VC Index (TRVCI) is published daily.

Performance - Total Return




